Hi Daniel,

As discussed, I've attached some imagery of some of the artwork Stephen Semmler has done in Port Wakefield at the bottom of the email.


There is another mural type image on the side of the Port Wakefield Soldiers Memorial Hall too featuring Pos Kipling and Sir Jack Brabham

The question we have is how this work is treated in the upgrade of Edward Street. Are we retouching and leaving as is, completely repainting or worked into as a hybrid so the existing work is encapsulated in new work around it.

What is the CMC's thoughts?

I have assembled a team to plan, design and deliver some indigenous art works at the entry of and into Edward Street, celebrating the township as a meeting place for the Narungga, Kaurna and Ngadjeri nations.

The same team (headed by Mike Makatron, Harley Hall and Ian Harradine) delivered the recently completed work on the Minlacowie Water Tank on Yorke Peninsula (see below).







Also, once I confirm if Dawn Fraser did indeed swim at the Tidat Pool, was considering having some form of statue made honouring her and her achievements utilising the skills of world-renowned artist, Robert Hannaford (based at Riverton).

Dawn has no local connection to the township other than the claim she swam there. There is no existing statue of Dawn anywhere in the world, despite the fact she is regarded as the finest female sprint swimmer of them all; winner of four gold and four silver Olympic medals, holder of 39 world records (27 of them individual) and first in her sport of either sex to win the same event at three consecutive Olympics. She is now one of four people in history to have achieved the feat.

It would be an incredible attraction to have her featured at the tidal pool, especially if Hannaford delivers the world, considering he did the statue of Bradman at Adelaide Oval and more recently, Queen Elizabeth II.




Semmler Art Work + Other Art Considerations


Thanks Daniel.
